- VENUE:** Allan Jones Intercollegiate Aquatic Center: An eight-lane 50-meter by 25-yard competition pool divided by a single 4-foot wide bulkhead, creating two 25-yard pools. The pool is outfitted with Omega - OSB11 sting blocks (28 inches above the water surface) with adjustable footrest wedges with extended platform surface. Additionally, retractable backstroke wedges may be attached. Pool depth is 8 feet at each end, 9 feet in the center. Lanes are 9 feet wide formed by 6-inch Competitor Lane markers. Warm-up/warm-down pool is located adjacent to the competition pool, with a minimum of two separate 25-yard warm-up/ warm-down lanes available. Seating is available for 1,284 spectators in the balcony overlooking the pool. Only coaches, athletes, officials, and other required meet personnel are permitted on the pool deck. Locker rooms are adjacent to the pool. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming

- RULES:** Current National Federation of State High School Associations (NFHS) Rules govern the conduct of these championships, except as modified by the TISCA Constitution and Bylaws, TISCA Championship Rules, or this Meet Invitation. It shall be the swimmers' and coaches' responsibility to acquaint themselves with all the information contained in the meet information.
- PENALTIES:** Per NFHS rules, "Competitors, once officially entered (unless scratched), shall compete in all races, heats, and rounds of competition (excluding swim-offs and legally declared false starts) for which they qualify... For failing to compete in all races, heats, and rounds for which the competitor has qualified or entered, the competitor shall be disqualified from further competition. The competitor shall not be disqualified from events in subsequent rounds for which the competitor has previously qualified. Previous performances are not nullified."
- OFFICIALS:** All swimming officials must be currently certified and 2025 members of USA Swimming. Officials desiring an assigned position must submit an application on the 2025 TISCA Official Application to the meet referee by February 2, 2025 (link: <https://forms.gle/fgdkquH5zwfodrXt8>). Dress code of white polo shirts with navy blue shorts, pants, or skirts and black shoes will be worn for all sessions. Contact for any questions: nicholashall55@gmail.com
- ELIGIBILITY:** This Championship meet is open to current TISCA member teams and athletes in good standing if meeting the requirements of Article VII and Article VIII and accepted by TISCA. All home school unattached swimmers must be registered with TISCA for the current season. No State Championship entries will be accepted from a team or unattached home school athlete unless current TISCA membership registration has been accepted and current dues have been paid. Registration forms and dues payment must be received by TISCA by the meet entry deadline. To register with TISCA, see full instructions at tisca.net → "Registration"

- CREDENTIALS:** Coaches, athletes and officials are required to display credentials to gain access to the pool deck. Credentials will be provided at Team Check-In. Teams will be allocated one coach/chaperone lanyard for every eight (8) competitors entered, up to a maximum of three lanyards per team. Lanyards will be allocated to diving coaches separately. No additional lanyards will be sold. Lost credentials for swimmers or coaches can be replaced by a coach for \$20, at the discretion of meet officials. Teams may request press/photographer passes through the TISCA Team Information form. Photographers will be required to complete a waiver before passes are issued.
- TEAM CHECK-IN:** Coaches and teams must check-in and receive their team packet and credentials before they will be allowed onto the pool deck. Early Check-In will be held on February 6, 2025, from 6:00 pm to 7:00 pm at Allan Jones Aquatic Center. Coaches may also check-in prior to the preliminary sessions on Friday and Saturday 6:30 am – 8:30 am. Team packets and heat sheets will be available at check-in.
- MEET FORMAT:** Prelim/Final meet with 24 events as set forth on the "Order of Events". There will be a championship & consolation heat (top 16) for all swimming events. The top 16 divers will return for finals. All events will be pre-seeded. For the Finals Session: All swimming and diving championship finalists will report to the ready area. Consolation finalists will report to the blocks.
- WARM-UP RULES & ASSIGNMENTS:** Southeastern Swimming safety guidelines and warm-up procedures will be in effect. **Coaches of multiple high school teams must request their teams to be assigned to the same warm-up. Teams may also request warm-up times on Thursday on a first-come, first-served basis when filling out the 2025 TISCA Team Information Online Form: [Click HERE for form](#).** Warm-Up assignments will be posted on the Tennessee Aquatics website when available.
- ENTRIES:** Each competitor may enter a maximum of four (4) events, no more than two (2) of which may be individual events and must have met the qualifying time in any entered event during the current season. A team is allowed four (4) scoring entries in each individual event.
- RELAY ENTRIES:** Teams are limited to one (1) scoring "A" relay per event. The "A" relay must consist of at least three members entered in at least one individual swimming event. One non-scoring "B" relay may also be entered with an entry time and must be designated as such on the entry. All members of a "B" relay must be qualified and entered in the meet in an individual swimming event. NOTE: By NFHS rules, a swimmer cannot participate in the same event on two different relay teams (e.g., "B" relay in prelims and "A" relay in finals). Once a swimmer competes in the event as part of one relay team, the swimmer is limited to that relay team only during that event.
- "RELAY ONLY" ENTRIES:** Teams may enter a maximum of one (1) "Relay Only" swimmer per gender into the meet. A "Relay Only" swimmer is a swimmer who is not entered in any individual swimming events. That swimmer is only allowed to compete on the team's "A" relays. Failure of a "Relay Only" swimmer to compete on at least one relay at the meet will result in a \$100 fine to the team, and the team will be prohibited from entering any "Relay Only" swimmers in the next State Championship Meet. "Relay Only" swimmers must be included in the team's original entry. *If you need to add a "Relay Only" swimmer to your entry without assigning him/her to a specific relay, click on the Entered check box next to the swimmer's name and then right mouse click. TM will ask you to confirm that you wish to enter this swimmer as a "Relay Only" swimmer.* Click OK and the "Relay Only" swimmer entry will be stored in your database and the column to the left of the swimmer's name will be listed with an @ character to indicate the "Relay Only" status. "Relay Only" swimmers will be displayed in the Meet Entry Report sorted "by name" with the "Individual and Relay" box checked. Note: If a diver wishes to participate as a qualified member of an "A" relay team, they must qualify for the meet in a "swimming" event. If a diver does not meet this qualification, he/she may be included as a "Relay Only" swimmer.
- NOTE – RELAY NAMES:** Coaches should designate four individuals per relay with the meet entry file. Relays may be entered without names, but preference is for four names to be included for meet administration purposes. (Note: The names of individuals designated in the meet entry file will NOT be included on the meet psych sheet.) Relay line-ups may be changed up until the relay card is due for that event. Do not include "alternates" in the meet entry file; they do not need to be declared. Any team member entered in the meet is available to swim the prelims, swim-offs, and/or finals of a relay event provided the competitor does not exceed the total permitted entries for the meet or event. Designation on a relay shall not count as an entry unless the competitor actually competes in the event.
- RELAY CARDS:** Relay cards will be due to the Clerk of Course as follows during both preliminary & finals sessions:
200 Medley Relay: one (1) hour before the start of the session

200 Free Relay: before the start of the 500 free

400 Free Relay: before the start of the 100 back

ENTRY TIMES: Enter with best SHORT COURSE YARDS times achieved in competition during the current high school season.

ENTRY TIME VERIFICATION: A swimmer who does not attain the qualifying time for an event during competition in this championship meet will be required to provide proof of entered time. The only valid proof of time will be official meet results from the meet where the time was attained. (Note: Any diver entered in the meet who fails to complete the event must also provide proof of qualification: results from three meets completed this season, at least one of which must be an 11-dive meet.) Failure to provide entry time verification within 30 days of the meet will result in a \$50 fine charged to the team per instance. Once 30 days have passed, then proofs will no longer be accepted and fines must be paid. Proof of time form & payment instructions will be distributed via email and made available at tisca.net. Please note that a team will not be allowed to participate in future TISCA Championship Swim Meets until all outstanding fines have been paid. If a team fails to provide proof of time in two consecutive seasons, then the team must pre-verify qualifying times for the following State Meet. Official meet results are defined as results achieved in high school competition or meets such as USA Swimming, AAU, or Y meets. "Exhibition" swims should be shown as part of the official meet results. A certified official who was present must sign Time Trial results. Team Manager reports are not valid proofs of time.

ELECTRONIC ENTRIES ONLY: All swimming and diving entries must be submitted via email using Hy-Tek Team Manager/Team Manager Lite or Team Unify. Entries must include the athlete first and last name, gender, and grade in school. USA Swimming athlete identification numbers may also be included. USE THE ASSIGNED TISCA STATE MEET TEAM ABBREVIATION FOR YOUR SCHOOL. The downloadable Team Manager EVENT FILE is available on the TISCA website (tisca.net) and Tennessee Aquatics Club [website](http://tnaquatics.com). USA SWIMMING OBSERVED STATUS: This meet has been approved for Observation of USA Swimming technical rules. USA SWIMMING OBSERVED TIMES Application for approval for Observation of USA Swimming technical rules has been submitted. If the meet is approved, those swimmers who are entered into the meet database with accurate USA-S ID numbers will have all times from legal USA-S swims automatically loaded into the national times database. The athlete's correct USA Swimming ID#, registered full name with middle initial and date of birth must be included in the TM entry. For those USA-S swimmers without USA-S ID's or inaccurate ID #'s, a written request must be submitted. Lead-off splits for individual events and relays must be specifically requested in writing. Requests must be made by submission of the SES Individual Verification Request Form by the athlete or coach within two weeks of the last day of the meet and submitted to the SES SWIMS Chair. Email requests are not acceptable. Forms are available at: www.seswim.org An LSC administrative fee of \$5.00 per athlete, payable to SES, Inc. must be submitted with the request. Note: Late fees of \$10 per athlete must be submitted for requests after the two-week time limit. SE Swimming, Attn: Tom Healey, 327 East Longleaf Dr, Auburn, AL 36832.

DIVING COMPETITION: Divers are required to dive in and complete at least three dive meets, at least one being an 11-dive meet, during the current high school swimming/diving season in order to be eligible to dive in the TISCA Championship Meet. All divers should have their score sheets showing successful completion of three dive meets available in case of any eligibility question. There will be three stages of competition: preliminaries, semi-finals and finals. There will be a minimum of five judges and one referee present for the competition. Competition will consist of five voluntary dives and six optional dives, which may be performed in any order within each stage of competition. The five voluntary dives must come from each of the five groups and the sum total of their assigned degrees of difficulty must be 9.0 or less. The six optional dives must include at least one dive chosen from each of the five groups. All five groups of dives must be represented in the preliminary and semifinal rounds (first eight dives). The dives to be performed during each stage of the championship competition shall be as follows:

Preliminaries (rounds 1-5): Any two voluntary dives, any three optional dives. If there are more than 32 divers, the field will be reduced to the top 32 following round 3 (at the discretion of the Diving Director). The top twenty divers will advance to the semi-finals.

Semi-finals (rounds 6-8): Two voluntary dives, one optional dive (this dive must be from a different group than those in the preliminaries). The top sixteen divers will advance to the Finals.

Finals (rounds 9-11): One voluntary dive, two optional dives.

DIVING SCORE SHEETS: Diving entries for Men and Women must be submitted on Divemeets.com by 1:00pm on Thursday, February 6. Sign-ups will NOT be accepted after the deadline. All divers are required to have an AAU Diving membership. AAU Diving membership will be needed for insurance purposes and in order to sign up using Divemeets.com. Coaches and divers will sign their dive list at the Dive Check-in Table (on pool deck, near dive well) once they arrive to Allan Jones Aquatic Center. A Dive Change Box will be available at the Diving Check-in Table. Changes are permitted until 60 minutes prior to the start of the diving competition. **ALL DIVERS MUST BE ENTERED IN HY-TEK OR TEAM UNIFY FILE THAT IS SUBMITTED ELECTRONICALLY.** If you have questions about entering your diver in Hy-Tek please contact meetentries@tnaquatics.com

SCORING: Scoring will be 20-17-16-15-14-13-12-11-9-7-6-5-4-3-2-1. Points will be awarded for first through sixteenth place for individual swimming and diving events. Double points will be awarded for relay events.

AWARDS: There will be individual awards for the top sixteen athletes in each individual and relay event. Medals for 1-16 will be awarded. Trophies will be presented to the top 10 teams in the Men's & Women's divisions. The Ray Bussard Combined Team Championship Award will be presented to the top 10 combined teams. Awards will be given out each evening throughout the course of finals on deck at the awards stand.

Additional awards to be presented at the completion of the Finals Session on Saturday:

- Female Swimmer of the Year
- Male Swimmer of the Year
- Men's Swimming Coach of the Year
- Women's Swimming Coach of the Year
- Female Diver of the Year
- Male Diver of the Year
- Diving Coach of the Year

ALL STATE AWARDS: Swimmers and Divers will be recognized by TISCA as "All State" by placing 1st through 4th in an individual or relay event. Awards for All State will be mailed to the athlete's team after the competition.

ANNUAL TISCA BUSINESS MEETING: The annual TISCA Business Meeting will be held 30 minutes after the conclusion of Friday's Preliminary session, location is TBD. Lunch will be provided. Elections and rule proposals will be voted on. Each team is highly encouraged to send a representative! TISCA is a coach-run organization, and participation by our coach members is paramount to sustaining our mission.

EXPECTATIONS: Per NFHS rules and TISCA by-laws, all athletes, coaches, volunteers and visitors are expected to hold themselves, teammates, peers and colleagues accountable to the highest level of sportsmanship, personal conduct and general behavior. Unsportsmanlike behavior exhibited by athletes will not be tolerated and will be addressed and punishable by removal from the meet at the discretion of the Meet Referee and Director. This is to include behavior exhibited at all times while onsite at the Allan Jones Intercollegiate Aquatic Center. The same standard will be held for all coaches, volunteers and visitors.

General Information

- PARKING:** Parking information will come closer to event timing as a separate email; info will also be posted to the TISCA site.
- USE OF AUDIO/VISUAL:** Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, on deck, in the restrooms or locker rooms. The use of drones is not allowed.
- DECK CHANGE RULE:** Except where venue facilities require otherwise, changing into or out of swimsuits other than in locker rooms or other designated areas is prohibited.
- FACILITY RULES:** Only Swimmers, Coaches and Meet Personnel shall be on the pool deck at any time. Credentials must be shown by swimmers and meet workers for access to the pool deck at all times. Lanyards must be worn by coaches for access to the pool deck at all times. No food or drink (with the exception of water bottles) may be brought into the pool area. No chairs may be set up in between or in front of the bleachers, including along the railing.
- CLEAR BAG POLICY:** The current University of Tennessee Clear Bag Policy will be in effect for all fans. Athletes will not be required to follow this policy, but must enter through the athlete entrance. Policy [HERE](#).
- SPECTATOR SEATING:** All spectators will observe the meet from the stands. The doors will open prior to each session as follows:
- Friday & Saturday Prelims – 6:30 AM
Friday & Saturday Finals – 4:30 PM
- ADMISSIONS:** Credentials will be allocated to coaches/chaperones and press passes will be available as detailed in “CREDENTIALS” section above. There are two tiers of spectator passes: Premium and General. **Premium ticket holders will have a better view of the swim competition pool and podium for Finals sessions only.** During Preliminary sessions, there is no separate Premium spectator section. During Finals sessions, there will be marked sections for Premium ticket holders. There will be no assigned seats; all seating is first come, first serve.
- ALL SESSIONS PASSES will be available for purchase ONLINE ONLY at a discounted price:**
- All Sessions – Premium = \$65
 - All Sessions – General = \$45
- The online sale will begin on Monday, January 27, and run through **Wednesday, February 5**. The ticket sale is available via the [Tennessee Aquatics](#) site and can be accessed directly here: tinyurl.com/StateTickets25. After the online sale ends, spectator passes may only be purchased at the door.
- Spectator passes will be available for sale on site in the Allan Jones Intercollegiate Aquatic Center lobby beginning Thursday, February 6, from 6:00 pm – 7:30 pm, and then again on Friday and Saturday morning beginning at 6:30 am. *Note that if you purchase your tickets at the door, you will only be able to buy a pass for the day of (ie, either Friday or Saturday).* Ticket prices at the door are the following:
- Full Day – Premium = \$40
 - Full Day – General = \$35
- BANNERS:** The AJIAC Facility Staff will hang all banners in the order in which they are received. **Teams must turn banners in by 8:00 pm on Thursday, February 6, to the AJIAC ticket booth.** Zip ties will be used to hang banners. **Individual teams are responsible for cutting down and taking their team banner with them at the end of the meet.** Facility staff will assist in taking down banners in any way necessary. Banners will not be stored at the facility after the meet.
- RESULTS:** Real-Time results will be available on the [TNAQ](#) website; results will also be posted to Meet Mobile.
- SWIMSHOP:** Swim and Tri will be available both days of the meet.
- CONCESSIONS:** Concessions will be available for sale in the Allan Jones lobby. No outside food or drinks may be brought into the building. No coolers may be brought into the building.

Incorporation of Paralympic Athletes into the Tennessee State High School Swimming and Diving Championship Meet

Philosophy and Rationale: The Tennessee High School Swimming and Diving Championship Meet is the pinnacle interscholastic competition for swimmers and divers in the State. As such, participation requires a level of competitive competence. Such competence in swimming is shown by equaling or bettering established qualifying time standards in each event. Competence in diving requires successful completion of at least one 11-dive competition prior to the State Meet.

The TISCA body has determined that providing an avenue for disability athletes to participate in the State Championship Meet has benefits to not only the disability athletes but to the organization and its members. However, in order to maintain the competitive philosophy of the meet, disability athletes must meet certain qualifying criteria. In other words: ***Participation by disability athletes shall not be awarded merely because one has a disability. Rather, the right to participate in the State Championship Meet shall be awarded based on the performance of a given standard which takes into account an athlete's disability.***

Logistics: To participate in the Tennessee State High School Championship Swimming competition, a disability athlete shall:

1. Show proof of USA Paralympic Sports Class Impairment. Such classification is a formal procedure carried out by the USA Paralympic Committee. TISCA is not able to nor responsible for providing such classification. Simply stating that one has a disability is not sufficient. Only USA Paralympic Classification certification will be accepted. Provisional sport classification documented by US Paralympics will be accepted, as will a final National Classification. For full information on classification from US Para Swimming, visit <https://www.usparaswimming.org/classification>.
2. Within the current high school season (i.e., beginning on Sept 1), meet the current Can-Am Swimming Meet time standards for his/her disability category in the course distance in which the event was swum. Proof of time is required prior to State competition. The "current time standard" will be considered to be the Can-Am Meet standards posted on the USA Paralympic website as of September 1 prior to the TISCA State Championship in question. To access these standards go to: <https://www.usparaswimming.org/standards>
3. Meet all other TISCA eligibility requirements, including Championship Meet Entry requirements.

Events: Qualified disability swimmers may enter the 50 and/or 100-yard freestyle events at the meet for which they qualify. They will be seeded by time along with able-bodied swimmers in the competition. There will be no separate awards or scoring for disability events.

Accommodations: Prior to the meet, coaches and athletes are responsible for alerting the meet host and referee as to any accommodation which may be required. Providing specialized accommodations (for example, a visually impaired swimmer needing a tapper) is the responsibility of the athlete and/or coach.
